Self-Assessment Tool for Fieldwork Educator Competency

Are you a seasoned fieldwork educator or just starting on this professional endeavor? Either way, you can benefit from completing this free self-assessment tool from AOTA. It allows you to determine your perceived level of competency as an educator in these 5 areas:

Professional Practice Education Supervision Evaluation Administration

Per the Commission on Education:

"Proficiency as a fieldwork educator is an ongoing process of assessment, education, and practice. It is essential for fieldwork educators to continually work toward improving their proficiency in all competency areas as they supervise OTA/OT students. Use of this assessment tool is intended to be the founda-tion from which each fieldwork educator will create a professional growth plan with specific improve-ment strategies and measurable outcomes to advance development in this area of practice."

ACOTE has finalized the new 2018 Accreditation Standards:

Visit the ACOTE site to become familiar with the new requirements for academic programs. The "C" standards impact academic fieldwork.

NOTE: C.1.3 "Ensure that fieldwork objectives for all experiences include a psychosocial objective." We must ensure that students are exposed to and understand the impact of psychosocial issues on client performance for all level I and II experiences.

Assistive Technology Workshop

The AT Seminar reviews a wide range of assistive technology by focusing on the areas in which the technology helps, rather than on the devices themselves. This concept allows for a broader range of devices to be discussed with pragmatic examples. Cross area comparisons are also provided in order to begin a movement towards a level of transparency within any classroom, therapy room, or even work-place setting. Participants of these seminars are engaged with the AT in a hands-on manner as well as learning various techniques for all abilities to use within inclusionary or even neurotypical settings.

The AT Seminar seeks to provide ideas on the best practices surrounding the devices. It offers support in creating holistic approaches for interactive learning for all students. And finally, it promotes the usage of assistive technologies in an effort to foster greater learning and everyday achievements for all.

Objectives

 \cdot Review the research behind assistive technology to understand the role that it plays in adaptive learning, therapy, and improving daily life activities for those with differing abilities.

· Identify how specific types of assistive technology function with specific needs.

• Receive hands-on learning with various types of assistive technology products, including switches, sensory feedback tools, and interactive devices like the TAPit, ProxTalker, GoVision OCR video magnifier, GlassOuse, and Movement Sensor Switch.

· Participate in open forum discussions with other attendees.
